3. Assumes all foregoing risks and accepts personal responsibility for any and all damages of any kind resulting from participating or attendance at the games.
4. Releases, waives, discharges, and covenants not to sue Massachusetts Senior Games, Inc., its successors, its affiliated clubs, sponsors, advertisers, owners, and lessors of premises used to conduct events, along with their respective administrators, directors, officers, board members, agents, coaches, coordinators, managers, employees, servants, and volunteers; and fellow participants in the games; and any other person or entity involved in the program, activity, or related event of the Massachusetts Senior Games, Inc.; all of which are hereafter referred to as "releasee", from any and all liability to each of the undersigned, his or her heirs and next of kin and his estate, for any and all claims or demands for any and all losses, injury of any kind, disability, death, or any damage of any kind, to person or property, caused in whole or part by the releasee.
